Jeanie Schmidt presented a written report on the status of Mid Rivers 911. The Board discussed the different options for cable at the center. It was decided to purchase a firestick and go with the Expanded Basic package.

Jeanie Schmidt presented a written report on clerk issues.

Questions and concerns were heard from the public.

Skupa read a partial list of grounding problems at Mid Rivers 911 from the report done by RVW Inc. A motion was made by Trambly and seconded by Pearson to contact an electrician to install a grounding bar at Mid Rivers 911. Roll call: aye-5, nay-0.

The Board discussed the options for cable at the Community Hall with no decision being made.

Discrepancy over possible taking of items without payment was discussed with all parties involved stating their side of the story. It was decided that a small payment should be made for the items.

A motion was made by Trambly and seconded by L'Heureux to accept the quote from Glenwood to install a Sensaphone dialer at the Sewer Lift Station for a one-time fee of \$557.80 /l and a recurring fee of \$4.00. Roll call: aye - 5, nay - 0.

A motion was made by L'Heureux and seconded by Lang to adopt Ordinance No. 19-3 authorizing the issuance of a General Obligation Bond, Series 2019, of the Village of Campbell Nebraska, in the principal amount of six hundred thirty-eight thousand and 00/100 dollars (\$638,000.00) for the purpose of constructing additions and improvements to the water system and moved that the statutory rule requiring reading on three different days be suspended. Roll call: aye — Lang, L'Heureux, Pearson, Skupa, Trambly; nay — none. Motion carried. A complete copy of the ordinance is on file in the clerk's office.

A motion was made by Skupa and seconded by Trambly to go into executive session at 8:49 a.m. to discuss an employee issue. Roll call: aye-5, nay-0

A motion was made by Skupa and seconded by Trambly to come out of executive session at 9:00 a.m.

A motion was made by Lang and seconded by Skupa to terminate an employee, effective immediately, due to individual's initial lack of action at time of incident and positive action by individual after incident. Roll call: aye – Lang, L'Heureux, Pearson, Skupa; nay – 0; abstain – Trambly.

November is National Alzheimer's Disease Month

Alzheimer's disease (AD) is the most common cause of disruption to mental functioning in people over 60. While normal aging slows down our ability to process and recall information, AD is significantly more destructive to the structure and function of the brain.

The Alzheimer's Association has put together a list of 10 Warning Signs of Alzheimer's. Probably all of us have had one or more of these things happen, and they do become more frequent as we age, but for AD sufferers, many of these events are happing often and the frequency and severity inexorably increases. This is sad evidence of the destruction occurring within the AD brain.

Currently 4 million Americans are estimated to be suffering from AD! This adds up to huge costs: the U.S. alone spends \$90 billion per year on AD, including medical costs, long-term care costs and loss of productivity. According to the National Institute on Aging, the number of Americans with AD is expected to triple in the next two decades.

At present, the cause of the disease is unknown and there is no cure, but there is hope that taking preventative measures now may lead to a memoryfilled future.

WARNING SIGNS OF ALZHEIMER'S

- 1. Memory loss that affects job skills.
- 2. Difficulty performing familiar tasks.
- 3. Problems with language, e.g. forgetting simple words or substituting inappropriate words.
- 4. Time and/or place disorientation, i.e. more than momentary confusion.
- 5. Poor or decreased judgment.
- 6. Problems with abstract thinking, e.g. simple math
- 7. Misplacing things, i.e. losing things in Obvious places or misplacing things in unusual places.
- 8. Changes in mood or behavior; may be rapid changes without apparent reason.
- 9. Personality changes.
- 10. Loss of initiative; lack of interest in usual pursuits.

Individuals who exhibit several of these symptoms should see a physician.


