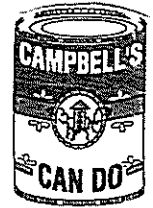

Absent: Nelson Trambly (excused). Jeanie Schmidt, Ron Pankoke, Ryan Kavan, Gary Derr and Crystal Simonton were also present.

Chairman Skupa called the meeting to order. Notice of the meeting was posted in three public places in the Village. The Nebraska Open Meeting Act is posted on the south wall of the Community Hall.

Questions and concerns were heard from the public.

Ryan Kavan with JEO Consulting Group gave a review of our one- and six-year street improvement program.

A motion was made by Pearson and seconded by Lang to appoint Ryan C. Kavan with JEO Consulting Group Inc. as the city street superintendent for 2020. Roll call: aye - 4, nay - 0.

A motion was made by Pearson and seconded by Skupa to appoint JEO Consulting Group Inc. as the village engineer for 2020. Roll call: aye - 4, nay - 0.

A motion was made by Lang and seconded by Skupa to approve the request by the Campbell Area Foundation to apply for a Special Designated Liquor License for their fund raiser on February 15, 2020. Roll call: aye - 4, nay - 0.

A motion was made by Pearson and seconded by L'Heureux to approve the building permit for Jeanie Schmidt for a deck on the west side of the house on Lot 3, Block 3, Second Addition. Roll call: aye - 4, nay - 0.

The Board discussed the purchase of a broom for the front of the mower. This agenda item was dropped for lack of a motion.

A motion was made by Pearson and seconded by L'Heureux to retain Skupa as chairman of the board. Roll call: aye - Lang, L'Heureux, Pearson; nay - 0; abstain - Skupa; absent - Trambly.

A motion was made by Pearson and seconded by L'Heureux to appoint members to the same committees as previously held. Roll call: aye - 4, nay - 0. Committees are:

- Finance - Lang and Skupa

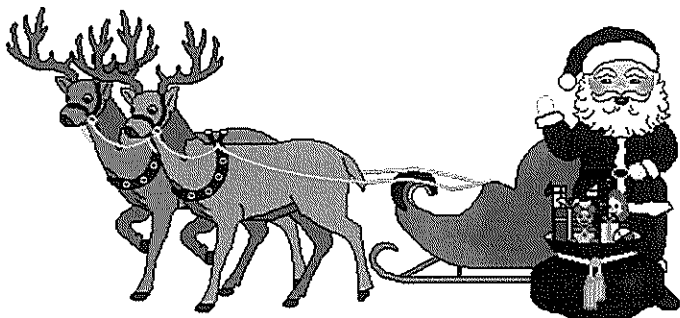


# CAMPBELL BLOODMOBILE
