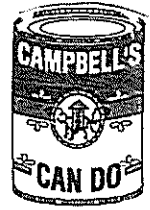

A motion was made by Skupa and seconded by Trambly to accept the bid from Midlands Contracting for sewer pipe repair at a cost of approx. \$10,00.00. Roll call: aye - 5, nay - 0.

The board discussed the sale of the ice machine at Grandview Manor with no action taken. The ice machine will be housed at the fire hall.

A motion was made by Pearson and seconded by L'Heureux to allow board to retain clerk as consultant/trainer past resignation date at a rate of \$15/hour. Roll call: aye - 5, nay - 0.

The board discussed complaint about vehicles behind station at 607 Broad St. with no action taken.

There being no further business, the meeting was adjourned at 9:04 a.m. to the call of the Chair.

The meeting was adjourned at 9:28 a.m. to the call of the chair.

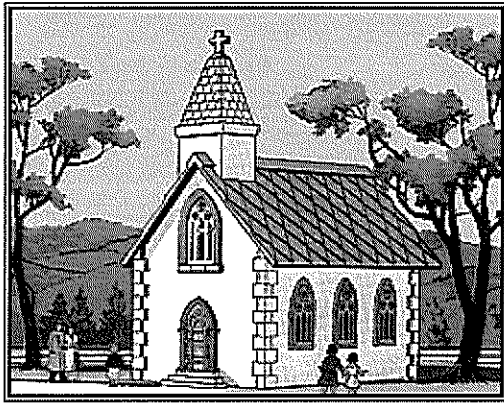
