The Village Board then recognized Rodney Lang for his years of serving on the Village Board.

A motion was made by Arntt and seconded by Trambly to put Village items up for sealed bid including chain link fencing, the old 911 tower, and a trailer. Roll Call: aye-5, nay-0.

A motion was made by Skupa and seconded by Arntt to approve the bid from Heins Construction to armour coat the streets for the amount of \$37,225.70. Roll Call: Skupa, Meyer, Arntt, Pearson aye-4, Trambly nay-1.

A motion was made by Trambly and seconded by Arntt to advertise for Village of Campbell maintenance position. Roll Call: aye-5, nay-0.

With respect to the building permit for the new fire hall, it needs to be noted before this motion and vote that there is some question as whether the actions taken to approve the building of this new fire hall were legal, was an agenda for the meeting that approved said building available for public viewing at least 24 hours prior to that meeting, with a vote for approving the building on said agenda and was that meeting legally advertised. Now do we have a motion concerning the building permit for the Fire Hall.

A motion was made by Trambly and seconded by Arntt to approve a building permit for Campbell Rural Fire Protection District. Roll Call: Meyer, Arntt, Pearson, Trambly aye-4, Skupa nay-1.

There being no further business, the meeting was adjourned at 8:31 a.m. to the call of the Chair.
